
Website Privacy Policy

All About Living Inc. is bound by the National Privacy Principles contained in the Privacy Act 1988 and the Privacy Principles (Privacy Amendment [Private Sector]) Act 2000 (Commonwealth). All About Living Inc. is committed to protecting your privacy in accordance with Australia's National Privacy Principles. You can be sure that we will only use your personal information as stated in this Website Privacy Policy. To assist you in making informed decisions when using the All About Living Inc. Website, please read through this Policy.

The purpose of our Website Privacy Policy is to explain how we collect, use and safeguard the personal information you provide to us when you visit and contribute to our Website.

Collection of Information

Information collected from you is primarily for two purposes:

- To customise your experience of the All About Living Inc. Website to make it more accessible to users, with more relevant content
- To ensure all contributed content is correctly attributed

There are two ways to access the All About Living Inc. Website: as an anonymous user, or as a registered user. The type of information gathered and used about you varies in accordance with your user status.

Anonymous Users

All About Living Inc. automatically gathers anonymous information to monitor the use of the All About Living Inc. Website, such as the numbers and frequency of visitors to each section of the Website, and the region from which access to the Website is gained. This information is collated from log files which record details of each Website transaction.

Registered Users

In order to publish content to the All About Living Inc. Website through participation in on-line forums, you are required to be a registered user. Users who chose to register with us will be asked to provide the following information:

- Your name
- Your organisation
- Your region
- Your email address
- Your contact telephone number.

When you chose to publish content on the Website, including comments and discussion-forum posts, be aware that your name and organisation will be displayed. This is to ensure proper attribution and public accountability of the

information published. No other information about you will be publically accessible.

As with anonymous users, each transaction conducted on the All About Living Inc. Website is automatically recorded in the log files of Website transactions.

Use of Personal Information

All About Living Inc. will primarily use the personal information we receive for the purpose of attribution of content you have published. We will not use any individually identifying personal information without your consent, with the exception of instances of breach of the Website Standard Conditions of Use.

The information collated from log files of Website transactions provides us with aggregated data only, and contains no identifying information.

It enables All About Living Inc. to determine the extent to which our users access different parts of the Website, to monitor customer demand and preferences. From evaluation of this data, All About Living Inc. can work to constantly improve the Website and its content relevance for users.

All About Living Inc. may use information from log files when investigating suspected breaches of the All About Living Inc. Standard Conditions of Use. For example, where the Website has been vandalised or material posted under another person's name without their consent, All About Living Inc. may access the log files to investigate the source and take corrective action.

All About Living Inc. may also use this information to investigate technical issues related to the performance of the Website. For example, a poorly behaving web spider may place excessive load on the Website. All About Living Inc. may use data collected in the log files to identify the source and take corrective action.

Cookies

When you access the Website as a Registered User, All About Living Inc. will also use your personal information to customise your experience. A cookie is a file a Website saves to your computer. It records information such as Website preferences so that when you re-visit the Website, those settings are recalled. Unless otherwise blocked within your browser settings, the All About Living Inc. Website will set a user's cookie to customise your user experience. If you choose not to accept cookies, they can be blocked through your browser options. All About Living Inc. uses two types of cookies: user cookies and session cookies.

User Cookie

The user cookie will store your user preferences as set when you registered. For users that have not registered, only your accessibility option will be stored.

Session Cookie

The session cookie will be set each time you visit the Website. This session cookie records that you have verified your identity by entering your password, enabling you to publish to the All About Living Inc. Website. The session cookie is automatically deleted once you close your browser window, or the time-out period has expired.

Disclosure

There may be occasions when All About Living Inc. is required by law to disclose the personal information we hold about you to third parties. In the event that All About Living Inc. is investigating inappropriate use or technical issues on the All About Living Inc. Website, All About Living Inc. may disclose information in log files to Internet Service Providers and law enforcement authorities, in order to further investigate the issue. In circumstances where illegal activity is suspected, All About Living Inc. may make log files available to law enforcement authorities.

By accessing the All About Living Inc. Website, you consent to us disclosing your personal information to third parties if we have reason to suspect that you have committed a breach of any of our terms and conditions, or have otherwise been engaged in any unlawful activity, and we reasonably believe that disclosure is necessary to the Police, any relevant authority or enforcement body, or your Internet Service Provider or Corporate Services Support Officer or as required or permitted by any law (including the Privacy Act).

Under no circumstances will All About Living Inc. sell or receive payment for licensing or disclosing your personal information.
